Transport documents / ____4 ____ shall be issued in English language.

The Demand shall be presented to us solely in paper form.⁵

The obligation under this guarantee shall be reduced by all amounts which, by order of the Applicant, are paid to the Beneficiary by us - or by the Applicant himself, in which case the reduction shall only become effective upon presentation to us of copies of the relative bank transfer or bank cheque, in each case under reference to the Underlying Relationship.

The obligation under this guarantee shall expire [as soon as the original of this guarantee has been returned to us by the Beneficiary or a third party for discharge, but it expires in any case at the latest]⁶ on ______. Any Demand must have been received by us at our address in ______ on or before the expiry of this guarantee.
